Circular

Attention to all R.M.P.s in the State of Uttarakhand

It has come to the notice of Uttarakhand Medical Council that in many places the Pathologist, Microbiologist, Biochemist, Radiologist etc who are registered with Uttarakhand Medical Council are giving their scan signatures for authentication of various pathological test reports to various medical diagnostic centres without physically verifying test results or even without visiting those centers. It is to inform that medical certificates, reports and opinions cannot be issued in the absentia and should bear physical signatures and Registration Number of Uttarakhand Medical Council.

Any reports generated bearing signature in absentia and without actual examination or physically verifying test results and findings etc by R.M.P.s is unethical, illegal and amounts to Professional Misconduct.

Further, to inform to all the R.M.P.s that :

- (1) a visiting consultant in a hospital shall only perform consultation procedures and not any surgery".
- (2) Super specialists - Four legal attachments in Clinical Establishment.
- (3) Specialist - Two legal attachments in Clinical Establishment.
- (4) Consultation - At any place irrespective of number is allowed.
- (5) Fee health camps are excluded from its ambit - Proper permission should be taken from the competent authority.

All R.M.P.s are hereby warned to refrain from unethical, illegal activities otherwise he /she will be liable for strict disciplinary action as per U.K.M.C. Act – 2002 & N.M.C. Act – 2019.
